# Annual Meeting 2022: Heavy Rains, Moderate Turnout

The Lake Conway Estates Residents' Association held its annual meeting on Thursday, September 15. Although the LCERA annual meeting in 2020 and 2021 were held outside at the LCERA lake lot, after a two-year hiatus due to COVID concerns, the First Baptist Church of Pine Castle on Hoffner Avenue once again accommodated our Residents' Association and facilitated use of its fellowship hall as the Association's meeting venue. Unlike pre-COVID times, however, the executive council decided to forego the covered-dish dinner prior to the start of the meeting.

All addresses in Lake Conway Estates received notification of the meeting date and location by U.S. mail 30 days before the meeting. Residents who had not been able to remit LCERA dues in advance of the event were provided a brief window of opportunity to pay their membership dues for Fiscal Year 2022/2023 before the meeting began. Payment prior to the start of the meeting enabled residents to take advantage of the discounted dues rate and helped establish the quorum required to proceed.

It was fortuitous that the meeting had been scheduled to be held inside at FBCPC because a heavy long-lasting rain storm moved into the area shortly before the meeting's start, and Association members were dry and comfortable inside the church's hall. Had the gathering been planned for the LCERA lake lot, it would have had to be rescheduled. Additionally, the fellowship hall provided amenities that would not have been available at our lake lot setting.

President Jason Hunter called the meeting to order shortly after 7:00 p.m.; a quorum was verified. A power point presentation was utilized to provide the minutes of the annual meeting for Fiscal Year 2021/2022 as well as the treasurer's report provided by David Sherard. The proposed budget for F.Y. 2022/2023 was approved. The presentation also addressed projects at the LCERA properties that had been completed and projects that would be undertaken in the new fiscal year, including re-roofing of the two pavilions at the lake lot. Resident volunteers who had taken the initiative to provide a service to our subdivision were acknowledged, including Mike and Emily Mannix for supplying event signs and David Meneses and Shirley Tjiong for providing and planting drought-resistant landscaping materials at the Darden and Hoffner wall planter box.

The main purpose of the annual meeting, of course, is election of a slate of officers for the Executive Council of LCERA. The slate proposed was President, Jason Hunter; Vice President, Bill Parker; Treasurer. David Sherard; Secretary, Chanelle Huff. There were no nominations from the floor. The proposed slate was approved unanimously. The position of Membership Chairman is an appointed one and is presently held by Rachel Tierney who has diligently kept membership and key card records up to date.

Therefore, each commissioner will be re-sworn into office in April of 2023 to continue serving their respective districts.

Of course, all ornaments, decorations and tree stands should be removed before the trees are placed at the curb, and trees taller than six feet should be cut in half.
