### Lake Lot Activities – March 25 & 26

Warmer weather that arrives with spring is always accompanied with increased use of the LCERA lake lot by members. After "winter" conditions, the first Residents'-Association-sponsored events in recent years have been the Lake Conway Estates Easter Egg Hunt and the LCERA annual picnic.

In the several years prior to COVID restrictions, the two events were scheduled on the same weekend in order to utilize---for both events---the rental tent, tables, and chairs that had always been ordered for the annual picnic. This year will be no exception. The two events will be held the weekend of Saturday, March 25, and Sunday, March 26.

Mortier Avenue resident and street captain, Lynn Armstrong, will again be organizing and conducting the egg hunt with the assistance of numerous volunteers on Saturday, March 25, beginning at 10:00 a.m. A larger-than-life Easter Bunny is expected to hop by for a photo op with children in attendance. The event is open to all neighborhood (LCE) children and grandchildren. Participation is *not* dependent on Residents' Association membership. Children must be accompanied, however, by an adult resident of Lake Conway Estates. The egg-hunt-by-age-group activities will include a story time, chalk drawing, and of course a visit with the non-verbal Easter Bunny who most likely will hop away after 10:45 a.m.

On Sunday, March 26, beginning at 2:00 p.m. the LCERA Annual Picnic will take place at the lake lot. All households attending are requested to provide a covered dish that will feed at least six persons. There is no admission fee for Resident's Association members; however, there will be \$5.00 fee per head which will be collected at the gate for adult non-members and guests of members. The Association will provide a meat entre and non-alcoholic beverages. The event will conclude at 6:00 p.m.

As in past years, attendance by Orange County firefighters and EMT's---complete with emergency vehicles---has been of interest to all demographics. Blood pressure readings always prompt interest, particularly for seniors. For the younger set, Kiwi the Clown and her assistant---who create balloon art and perform face painting---is an ever-popular addition.

To prepare for the busy weekend events on March 25 and 26, the lake lot facilities and boat ramp will be unavailable for use beginning the morning of Friday, March 24 through Monday morning, March 27.

Those who are able are encouraged to walk to the event. No parking will be available within the lake lot property, but parking on surrounding area streets is an option.

## Déjà vu

Long-time residents will recall the days when every street entrance into Lake Conway Estates from Hoffner Avenue was flanked on each side by masonry columns; and on each column, the name of the of the appropriate street was affixed with large wooden letters. The pillars visually identified and unified our subdivision. Over subsequent decades, some columns were routinely maintained by neighbors; others, however slowly deteriorated.

Eventually, as a brick wall was being considered for construction along properties in LCE that bordered Hoffner Avenue, it was decided that *both* a brick wall and the existing columns would not be aesthetically pleasing, and many property owners agreed to the removal of the columns, anticipating the construction of a brick wall. There were some holdouts, however.

# In Belle Isle

### A Fond Farewell

Two highly regarded Belle Isle public servants recently announced their imminent departures from leadership roles within the City. Early in February, Belle Isle Police Department Chief, Laura Houston, declared her plan to retire Chief Houston assumed leadership of BIPD in 2016 after having served as Deputy Chief under Chief Rich Ring who resigned. Shortly after being named Chief, her mettle was tested when Belle Isle police officers were among the very first responders to answer the call for assistance at the Pulse Nightclub nearby on Orange Avenue in Orlando where 49 people were killed and many more injured on June 12, 2016.

Chief Houston has been a prolific grant writer who has enabled BIPD to benefit from grant awards that have facilitated the purchase of state-of-the-art technology and programs that keep the BI Police Department up to date with best practices in modern community policing. Deputy Chief, Travis Grimm was sworn in as Acting Police Chief at the BICC meeting on Tuesday, March 7. Lt. Jeremy Millis was sworn in as Deputy Chief. Both officers have served Belle Isle for multiple years and have demonstrated meritorious service.



At the February 21 BI City Council meeting, City Manager, Bob Francis, declared his intention to resign from that position by providing the contractually-required notice. Mr. Francis is a well-credentialed city manager who had been a front runner for the position over numerous other candidates for the post when he was hired by City Council in April of 2017. An Air Force veteran, he has served the City well, wearing many hats, and his work weeks have always been well in excess of 40 hours. The City Manager has kept the council fully informed as to the financial condition of the City and its future needs. He has also overseen the staff at city hall and has directed and supervised city departments, he has seen to the enforcing of laws and provisions of the council and has prepared and submitted the annual budget. He has facilitated the creation of numerous citizen advisory boards and committees to promote citizen input, oversight and participation in City government.

In typical fashion, Bob Francis has worked to enable a smooth transition for an incoming Acting City Manager when a candidate is selected by city council. The Acting City Manager will see to the day-to-day administration of City business until BI city commissioners select a credentialed applicant to hire for the city manager position.
